ECF Changes & Updates

This section includes information regarding changes and updates to ECF events, menus and the way the system processes information.

Objection to Notice of Mortgage Payment Change




Figure 1 event selection screen

New event [Bankruptcy > Claim Actions > Objection to Notice of Mortgage Payment Change] has been created and is available for use when appropriate (see Figure 1).

The event will allow the filing of an objection whether or not the proof of claim is on file with the court.

If the **proof of claim has been filed with the court**, the objection can be linked to the claim in the register, and the entry will appear in the Claims Register as a doc. (see Figures 2-4)



Figure 2 Claim question




Figure 3 Link to existing claim




Figure 4 Claim register

If the **proof of claim has not been filed with the court**, the objection can be linked to the event on the docket sheet, and the entry will appear on the docket sheet with a docket number. (see Figures 5-7)


