PAYMENT OF DIVIDEND FROM UNCLAIMED FUNDS

This event has been modified to allow external users to file an application for payment of dividend from unclaimed funds in CM/ECF. For attorney users, the event is located in [Bankruptcy → Motions/Applications]. For Limited Use Filers, the event is located in [Bankruptcy → Claim Actions].

Additionally, fund locator services are now able to register for Limited Use Filing privileges in CM/ECF, following the current procedures for CM/ECF filing registration. Fund locator services will have access to the same events as any other Limited Use Filers.

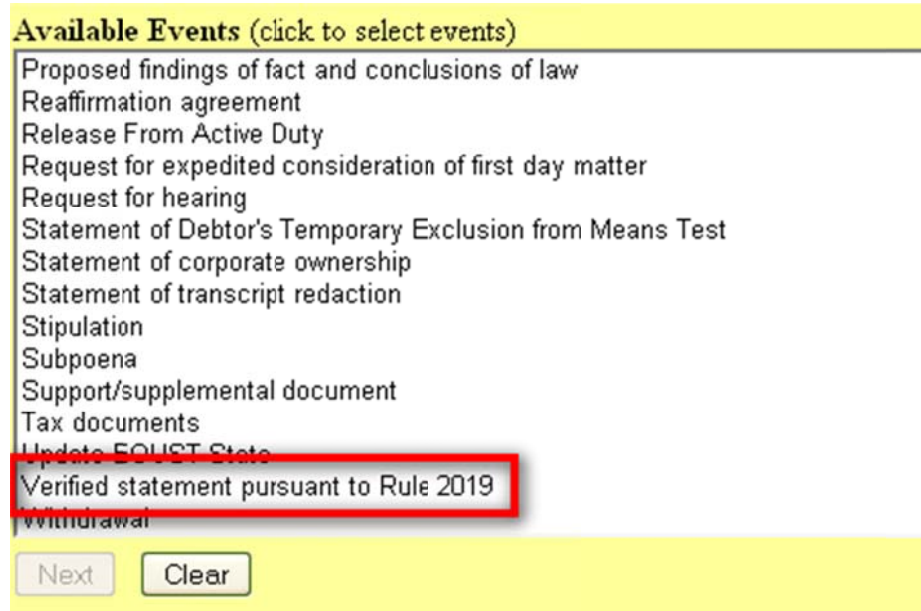
