<u>Step 2</u>

In order to hear the audio, you **must <u>save</u>** the PDF to the computer. The paperclip for the audio will only appear after the document is saved.

<u>Step 3</u>

Open saved PDF in <u>Adobe Acrobat</u>. Click on paperclip link in the document tools.



Once paperclip is selected the audio will appear.



<u>Step 4</u>

<u>Save</u> the audio to the computer. In order to hear the audio, you **must** save the audio clip to the computer. Without saving the audio, only a portion of the audio can be played. The full audio is played once the audio file is saved to the computer.
